# SUMMARY OF ACTIVITIES

## Donors and Friends:

We are again extremely pleased to share with you that an independent audit of PHCS Foundation, conducted by PricewaterhouseCoopers, resulted in an unqualified opinion.

As has been our practice, the audit was conducted in accordance with accounting standards generally accepted in the United States. Those standards require that our auditors plan and perform the audit to obtain reasonable assurances about whether the financial statements are free of material misstatements.

The financial statements are the responsibility of the Foundation's management. The annual audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. It assesses the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation.

The Foundation's investment portfolio is managed by SEI Investments, with oversight provided by a joint Investment Committee of the PHCS Board of Trustees and the PHCS Foundation Board of Directors. All *Design for Healing* capital campaign contributions were maintained in short-term holdings at PNC Bank and Wells Fargo Bank. Long-term investments held at SEI attained a 1.2% positive rate of return for 2011.

We are pleased to announce that gifts and pledges received for 2011 totaled more than \$19 million. We can also report that, with 2011 operating expenses totaling \$3.79 million, the cost of raising a dollar was 20.3 cents. Our thanks go to the PHCS Audit Committee, along with the PHCS Foundation Finance Committee, for reviewing the full report in detail. ## IN 2011

In addition to the funds raised for the new building project as well as funds raised for restricted purposes, the Foundation returned \$1 million to PHCS to support capital needs and for programmatic enhancement in the current hospital.

\$727,318 was raised in restricted support of the Art for Healing Program, the community clinic, nursing education, the Religious Ministries Program, and the Hospice Program.

\$2,004,128 was raised in unrestricted monies.

---

\$16,333,249 was raised in support of the new University Medical Center of Princeton at Plainsboro.

Thanks to our Annual Fund, the Foundation aided continuing operations through the purchase of equipment and by supporting ongoing patient care needs, community health services, and comprehensive training for PHCS staff to ensure a smooth transition to our new facility.
