PHCS Foundation Summary of Activities



Donors and Friends,

We are once again extremely pleased to share with you that an independent audit of Princeton HealthCare System (PHCS) Foundation, conducted by PricewaterhouseCoopers, resulted in an unqualified opinion.

I would like to thank all of the members of the Finance Committee for their hard work and dedication, and in particular to thank Duncan MacMillan, Treasurer of the Foundation Board of Directors and Chair of the Foundation Board's Finance Committee. Mr. MacMillan, who worked closely with Bruce Traub, our former

Chief Financial Officer, has ably handled the role of Treasurer for these past seven years. With Mr. Traub's departure, I would like to welcome Glenn Zirbser, our new CFO, who will also take on the responsibilities as Assistant Treasurer of the Foundation.

As has been our practice, the audit was conducted in accordance with accounting standards generally accepted in the United States. Those standards require that our auditors plan and perform the audit to obtain reasonable assurances about whether the financial statements are free of material misstatements.

The financial statements are the responsibility of the Foundation's management. The annual audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. It assesses the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation.

The Foundation's investment portfolio is managed by SEI Investments, with oversight provided by a joint Investment Committee of the PHCS Board of Trustees and the PHCS Foundation Board of Directors. All *Design for Healing* capital campaign contributions were maintained in short-term holdings at TD Bank and Wells Fargo Bank. Long-term investments held at SEI attained an 11.2% positive rate of return for 2012.

We are pleased to announce that gifts and pledges received for 2012 totaled more than \$19 million. Additionally, in 2012, the Foundation received notification of intended bequests totaling \$735,000 naming the Foundation as beneficiary. In total, the Foundation has been notified of 13 bequests with a current value of \$1,562,500. Because of the revocable nature of these gifts, they have not been recorded as part of the Foundation's assets.

We can also report that, with 2012 operating expenses totaling \$3.39 million, the cost of raising a dollar decreased to 18 cents. Our thanks go to the PHCS Audit Committee, along with the PHCS Foundation Finance Committee, for reviewing the full report in detail. In 1919, Moses Taylor Pyne, a distinguished philanthropist in turn-of-the-century Princeton, donated a five-acre farm at 253 Witherspoon Street as the site of Princeton Hospital. On this tract a farmhouse was converted to a 22-bed hospital with an operating room, and Princeton Hospital began its service to the community. The Moses Taylor Pyne Society recognizes donors who characterize Pyne's vision, leadership, and commitment to the community. Pyne Society donors who contribute critical support of \$10,000 or more annually to Princeton HealthCare System receive numerous recognition benefits and patient amenities provided by the PHCS Foundation during hospital visits.
