All patients are evaluated and followed by a psychiatric provider (psychiatrist or psychiatric advanced practice nurse), and participate in a full schedule of therapy, psycho educational groups, allied clinical therapies, and services specific to their individualized treatment plan, including nursing and nutritional consults as needed. Due to current telehealth regulations, out-of-state residents are only seen in-person.

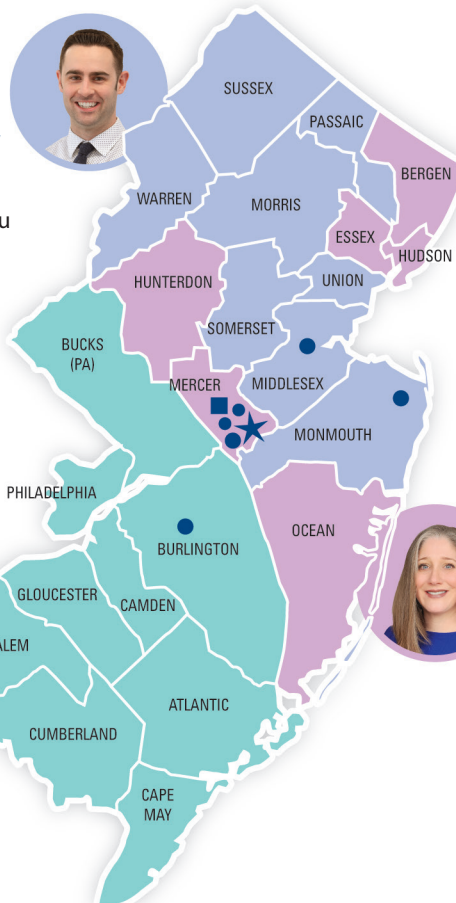
